

## **The Cowan Foundation donates \$250,000 to help address homelessness in the Region of Waterloo**

**Kitchener, Ontario** – The Cowan Foundation is donating \$250,000 to Indwell to help address the housing crisis in the Region of Waterloo.

On Friday, March 13, The Cowan Foundation will present the cheque at St. Mark's Lutheran Church—the future site of Indwell's first affordable housing program in the region. This contribution is a critical component in the funding of this project, as Indwell is to finalize the purchase of St. Mark's in June 2020.
